## **OLD BUSINESS**

#### **UPDATE: APPARATUS PURCHASE**

Chief Wallace informed the board that the district will be choosing the paint scheme for the new apparatus this week. Once the paint scheme is chosen the delivery of the apparatus should occur within three to four weeks.

## **NEW BUSINESS**

#### STATION 3 – CONNECT EXISTING BUILDINGS

Chief Wallace and Jonathan Davis discussed the construction of a 1,500 square foot awning between station 3 and the mechanic building. The district requested quotes from several places but received only 2 quotes, one from Cochran Construction for \$38,760.40 and a second quote from American Steel & Construction for \$30,180.00. The district will move forward using American Steel & Construction to construct the awning.

#### **DISCUSS T BILL INVESTMENT(S)**

Chief Turner informed the board that if the interest rates on the T Bills were similar to the rates at this time last year it would be worth purchasing T Bills to receive more interest than the district would receive if funds remained were they are now. Chairman Barnette asked about the current rates and how much interest could potential be gained. Chief Turner informed the board that rates could change daily and stated that if rates were four percent a five-to-eightmonth T Bill could generate anywhere from twenty to fifty thousand dollars depending on the amount invested. Chief Turner stated that even rates as low as two percent could generate fifteen to thirty thousand dollars.

**MOTION** was made by <u>JASON MCGINTY</u> and seconded by <u>JAY VALENTINE</u> to approve investing no more than two million dollars for a period of five to eight months in T Bills. Chairman Barnette called for public comment; there being none, vote was taken and the motion carried unanimously.

A list of items to declare salvage was provided to the board. The list included fifteen portable radios that have been discontinued and are obsolete, a charger for the obsolete radios, two obsolete AEDs, four 700 MHz radios that are no longer functional, 2 damaged firefighter helmets, and one pair of structural firefighting gloves (Lost).
