Chief Wallace stated that BFD4 has been receiving calls asking about the rating. Stephanie Collier asked if the town could do anything to improve the rating. Chief stated that there was nothing at this time. BFD4 will be working to improve the rating in the future. Stephanie Collier stated that the town will be looking into a hydraulic study for the hydrants in the future.
